

"EXHIBIT A" TO BYLAW NO. 112/87

This agreement made this 9th day of November A.D., 1987,

Between: The Town of Colonsay,
in the Province of Saskatchewan
hereinafter referred to as "the Town".

And: The Rural Municipality of Colonsay No. 342,
in the Province of Saskatchewan,
hereinafter referred to as "the R.M.".

This agreement witnesseth that in consideration of these presents and covenants, Promises and agreements hereinafter contained, the parties hereto jointly and severally agree as follows:

1. In this ByLaw, including this Section:
 - a) "board" means the Colonsay Recreation Board.
 - b) "Council" means the Council of the Town of Colonsay and the Council of the Rural Municipality of Colonsay No. 342.
 - c) "Municipality" means the Town of Colonsay and the Rural Municipality of Colonsay No. 342.
 - d) "Program" means those activities normally carried on in Culture, Recreation and Sport.
2. The Town of Colonsay shall designate by resolution one member of Council as a member of the Recreation Board.
3. The R.M. of Colonsay shall designate by resolution one member of Council as a member of the Recreation Board.
4. In the event of any financial assistance made available to the municipal governments, funds will be channelled through the municipal structure and distributed to various organizations by the board.
5. The Municipal Councils shall receive and turn over to the board grants they may receive for recreational purposes.
6. The recreational facilities are located in and owned by the Town of Colonsay, it is agreed that the Town of Colonsay shall carry and maintain adequate structural, casualty and public liability insurance on the said recreational facilities and associated programs administered by the Board, who shall then charge one half of the costs to the R.M. of Colonsay.

- 7. Audit fees shall be paid by the Town of Colonsay, who shall then charge one half of the costs to the R.M. of Colonsay.
- 8. The Treasurers Bond will be paid for by the Town of Colonsay, who shall then charge one half of the costs to the R.M. of Colonsay.
- 9. Both Municipal Councils shall contribute funding on a yearly basis for the operation of the board, upon the request of the board, providing such request is justifiable.
- 10. The Town of Colonsay and the R.M. of Colonsay agree that the board shall endeavor to make all the recreational facilities and programs available to all residents of the Town and R.M. on an equal opportunity basis.
- 11. The Town of Colonsay and the Rural Municipality of Colonsay mutually agree that this agreement shall be continuous and re-negotiations of any or all terms may be initiated and undertaken at anytime on the recommendation of the Board and/or mutual agreement of the elected officials of the Town and R.M.
- 12. In the event that either party desires to withdraw from or otherwise terminate this agreement, that party shall give at least one year's notice in writing to that effect to all other parties concerned. Such notice shall be given on or before October 31st to be effective on October 31st in the year following.
