BYLAW NO 5/2019

A BYLAW CONCERNING THE ERECTION OF HIGHWAY TRAFFIC SIGNS

The Council of the Rural Municipality of Colonsay No. 342 in the Province of Saskatchewan enacts as follows:

- 1. In this Bylaw the expression of "road" means any public highway within the municipality as defined in the Highways and Transportation Act, 1997, other than a Provincial Highway as designated pursuant to such act.
- 2. "Stop" signs shall be erected at the intersections of roadways at the following locations:

- 4. All signs erected pursuant to section 2 shall be erected not less than 3 metres and not more than 15 metres from the near edge of the intersected roads.
- 5. The provisions of the vehicle act shall apply, wherever applicable, to every sign erected pursuant to section 2.
- 6. No person shall alter, damage, remove, deface, knock down or tamper with any sign erected pursuant to this bylaw.
- 7. Any person who violates any provision of this bylaw shall be guilty of an offence and shall be liable on summary conviction to the penalties in the general penalty bylaw of the municipality.
- 8. Bylaw No. 1-78 is hereby repealed.
